



# WESTLAKE VILLAGE LOCAL APPOINTMENTS LISTS ADVISORY BOARDS

In accordance with Government Code Section 54972, on or before December 31 of each year, the City of Westlake Village must post a list of Advisory Members whose terms will expire during the following year. This list must include the names of the incumbents, the date of their appointment and the expiration date of their terms.

## CULTURAL RECREATION ADVISORY BOARD

Purpose: Assist the City in raising the overall level of awareness and importance of Cultural and Recreational activities in the community.

Membership: Minimum of 9 adult members and one youth member, a sophomore in high school. The Board shall not exceed a maximum of 15 members. All Advisory Board members shall reside within the City limits of Westlake Village. Members shall not be officers or employees of the City. The appointments shall be made by the City Council. All members, returning and new shall serve a two-year term.

## COMMUNITY SERVICE FUNDS ADVISORY COMMITTEE

Purpose: Review Grant Applications and make recommendations that provide community and cultural programs to Westlake Village resident. Not-for profit organizations that serve the residents in the greater City of Westlake Village community are eligible to compete for the funding.

Membership: The composition of the Community Service Grant Advisory Committee was established through a process in which each Councilmember appointed one member. Committee members shall reside within the City limits of Westlake Village. Committee members may serve no more than three terms. Each term is one year in length.
